IV. STATEMENT OF PUBLIC MEETING NOTICE

This Special Meeting of March 31, 2017, of the Board of Education of the Borough of North Arlington, in the County of Bergen, State of New Jersey, is called pursuant to meeting advertised on March 28, 2017, and of notice given to the Clerk of the Borough of North Arlington and to the Librarian of the Free Public Library of North Arlington for posting therein as election notices are posted and of notice given to the Editors of the following newspapers: Bergen <u>RECORD</u> of Hackensack, and the Newark <u>STAR-LEDGER</u>.

BE IT FURTHER RESOLVED by the North Arlington Board of Education that it is anticipated that this closed session will last approximately two (2) hours.

Discussion regarding:

- 1. The Superintendent provided the Board with a status update in regard to a tentative agreement with Bergen Community College. (BCC) A Memorandum of Understanding is being finalized between by Fogarty & Hara and BCC attorneys which will hopefully be presented to the Board of Trustees at Bergen Community College. Once the agreement is approved by Bergen Community College, it will be presented to the Board of Education at the April 24th North Arlington Board of Education meeting.
- 2. The Superintendent discussed the possibility of discontinuing the relationship with Passaic County Educational Services Commission Summer Program held at the middle school due to several issues over the years related to out of district students. The Superintendent recommended that this would be the last year the program is offered in order to give families and program coordinators sufficient notice. The Board agreed that summer school will be dissolved.

The Board convened in closed session at 4:10 pm.

Open Session reconvened at 6:50 pm.

A. WHEREAS, an employee whose name is on file in the Board office has an individual employment contract with a thirty (30) day notice provision; and

WHEREAS, the Superintendent has recommended that the Board invoke the thirty (30) day notice provision to terminate said employee's individual employment contract; and

BE IT FURTHER RESOLVED that the Board Secretary/Business Administrator shall provide the employee with notice of the Board's action as set forth in this Resolution forthwith.
