VII. HEARING OF THE PUBLIC

Fred Kurtz, 55 Morgan Place, NA – asked if the High School Band could play the National Anthem at the Boys Basketball Tournament game on March 3, 2014. The Superintendent thanked Mr. Kurtz for his wonderful suggestion.

Mr. Kurtz then inquired for clarification of Item H on the agenda. Mr. Curioni, Assistant Superintendent and Child Study Team Supervisor explained that despite the County projection of thirty-two (32) students, every district must apply for a waiver. Participation in the Special Education Medicaid Initiative is mandatory for districts that have forty (40) or more students.

Tom DeCara, 11 Park Avenue, NA – stated the Board of Education did an excellent job in snow removal around the schools during our numerous storms. He was also gratified to see the Board of Education employees assisting the Borough employees with snow plowing. Mr. DeCara also stated he attended a basketball game at the Middle School and was happy to notice that the roof leak had been repaired.

Mr. DeCara asked the Board when the construction at Rip Collins Field will begin. Mr. Ricciardelli stated that pending weather contingencies, very shortly.

Wanda Peguero – inquired about the CCSS and PARCC. The Superintendent responded there has been criticism of PARCC in the state and national educational community at large, however, the district staff have been working diligently in alignment of curriculum with the CCSS and PARCC to give our students the best opportunity for success, and that Principals will be reviewing this with PTOs.

Justification:

The Buildings and Grounds Supervisor advises that the new location of the generator created a change in where the buses are parked. The outlets are needed for the engine heaters on the buses. The cost of the installation will be covered by a credit for a gas pipe that was not installed in the generator project.
