A. MOTION TO APPROVE THE ACCEPTANCE OF THE BID FOR RENOVATIONS AND ALTERATIONS ON THE FORMER QUEEN OF PEACE HIGH SCHOOL

**WHEREAS,** the lowest bidder, Billy Contracting and Restoration, Inc. ("Billy Contracting"), submitted a base bid in the amount of \$2,083,000, together with Alternate No. 1 in the amount of \$58,000, for a total contract sum of \$2,141,000; and

**WHEREAS**, the bid submitted by Billy Contracting is responsive in all material respects and it is the Board's desire to award the contract for the Project to Billy Contracting.

**BE IT RESOLVED**, that the Board awards the contract for the Project to Billy Contracting in a total contract sum of \$2,141,000.
